URBAN HEALTH PROJECT	<p>IPE Global is implementing Partnerships for Affordable Healthcare Access and Longevity (PAHAL), a 5 year project, in Cooperative Agreement with USAID that aims to reduce preventable morbidity and mortality among women and children in urban areas by increasing access to and utilization of high quality healthcare services with a special focus on MNCH and FP services by leveraging private sector Inclusive Business Models (IBMs) in healthcare. With this strategic framework the program aims that 10 million urban poor will have access to quality primary healthcare services resulting in a reduction in the Out of Pocket (OOP) Expenditure. The Project will be covering urban communities in Rajasthan, Odisha, Telangana, Andhra Pradesh, West Bengal and Madhya Pradesh and will scout for potential partnerships and expansion in other high focus states for USAID.
